

DEAR
FRIENDS

t is an age-old tale about the power of one. In the following pages are real life stories collected from the lived experience of those touched by our many Catholic Charities programs. They are stories of the power of one to transform hearts, change lives... and make a difference. This is the work of Catholic Charities, and thanks to each and every one of you – our supporters, colleagues, and volunteers – we are able to do just that. Our ultimate goal? To end poverty one person at a time. It is more than a slogan on a billboard, it is our reason for being. ★ Poverty - both spiritual and material - takes many forms. Essentially, poverty is living without the necessary resources to survive, thrive, and reach one's full potential as a child of God. We may not eradicate poverty in our lifetime but, together, we try very, very hard. We may not be able to protect all the weak and vulnerable, but when they cross our path we welcome them as brothers and sisters, give them a place at the table, and empower them with the currency of their own dignity and worth. This is the Catholic Charities difference. Remembering the parable of the Good Samaritan, we are reminded that we are called not merely to admire him, but to act as he did. We may not touch every heart, but we transform more than we know, understanding that even one can make a big difference to countless others. Especially when that transformed heart is our very own and we realize we are all poor and in need... one way or another. Only then do we understand that we are one Body, one Spirit, many parts of one whole and, as such, called to love, serve, teach, and work for justice... for all. ★ These are the values of Catholic Charities and this year we were directly challenged to live those values in a most unexpected way as waves of unaccompanied children from Central America arrived at our border. Driven from their native countries – where terror and murderous violence reign – these brave children made their treacherous journey across desert and wilderness in search of safety and refuge. Catholic Charities welcomes and cares for these children just as the Samaritan welcomed and cared for the stranger at his border. This year, we hope to provide for 50 of these children at a time at our St Vincent's Villa in Dulaney Valley. Each child will receive a variety of care – including education, healthcare, counseling, recreation, and legal services – as they await family reunification. And our professional staff, trained in treating children who have experienced terrible trauma, will compassionately meet the needs of each vulnerable child. Our Esperanza Center in Fells Point also provides immigrants with important social support including immigration legal services, language classes, and healthcare. In the past year, they have reunited 481 unaccompanied minors with family members. You will read about one of those families on pages 10 and 11. ★ In a further commitment to ending poverty, Catholic Charities has undertaken a major expansion of one of its programs right here at home. This year, our St. Jerome's Head Start Program increased the number of children and families they serve in Baltimore City from 276 to 667 and the number of sites from 9 to 15. As you will see on pages 8 and 9, we offer the children of Baltimore the best opportunities for success not only in school, but in life. ★ Our other stories tell similar tales of those in need, uncertain to whom or where to turn until finding help through one of our 80 programs. They are stories of hope and transformation, grace and transcendence. As always, one can never be sure whose cry is most heartily answered...the caregiver or the cared for. Theirs is a shared experience. Both are Christ. "*Truly I tell you, whatever you did for one of the least of my brothers and sisters, you did for Me.*" Our theme dares to suggest we can end poverty one person at a time. This report shares how the power of one makes that possible. One by one, the numbers add up (pages 16 through 25). Eighty programs. Two hundred locations. Two thousand employees. Thirteen thousand donors. Twenty-three thousand volunteers. And over one hundred sixty thousand individuals and families for whom Catholic Charities makes a huge difference every day. Thanks to the power of one. Thanks to you.



Charles Bennett, age 73 and retired, is a college graduate and Vietnam vet. Over the course of his prolific albeit checkered career, he has been a middle school teacher, band leader, and basketball coach in North Carolina; a personnel analyst and insurance agent in New York City; a university professor in Pennsylvania; a director of youth services in Delaware; as well as a husband, father and caregiver. He has also been an alcoholic and a drug addict. Sadly, his addictions got the best of him, forcing him from job to job, city to city. ★ “I took a look in the mirror one day and all I saw was despair. When I think of all the things I could have achieved and didn’t...” His voice trails off. He doesn’t need to finish the sentence. We’ve all been in that place of regret and disappointment at one time or another. Eventually, Charles ended up in Baltimore where his cousin Earl, disabled by a stroke, needed his help. Taking care of Earl and his wife, Lucille, who suffered from dementia, became his full time job. Charles did everything for them. ★ “By helping them, I began to help myself,” Charles explained. ★ Yet Charles’s problems were far from over. Though he had begun treatment, he still struggled with his addictions. And when both Earl and Lucille died and their house was sold, Charles found himself homeless, a place he had never been before, not even in his darkest days. To make matters worse, in his advancing years he had developed some ailments of his own including heart problems, prostate cancer, and COPD. In his 60’s, he was just beginning to turn his life around, but despair still lingered. Thanks to Catholic Charities, it would not last long. ★ Charles first found housing at Holden Hall, a Catholic Charities residential program for disabled men where Charles received all the care and services he needed to achieve and maintain his sobriety and health. “To say I was relieved is an understatement,” Charles admitted. “Benton, the manager at Holden Hall, he saved me. He did everything for me. As the hymn goes, ‘I was lost, but now I’m found’. Truly.” Recently, Charles moved to Basilica Place, a Catholic Charities Senior Community located in the Mount Vernon area of Baltimore. At Basilica Place, Charles is part of the community. He has been clean for 6 years now and has never been happier. ★ “I love it here. The people are nice, the apartments are beautiful, it’s safe and secure. I spent my whole life moving from place to place but never really had a home. This is home. Catholic Charities makes it home,” Charles explained. ★ Catholic Charities has developed, operated, and managed affordable, supportive communities for eligible seniors with disabilities and limited means for over 30 years. We now have 24 communities throughout the state, serving 2,175 individuals in need. ★ As for Charles, he doesn’t dwell so much on regrets anymore. He prefers to think about those he may have helped along the way. ★ “One way to help myself is to remember that maybe I did have a positive impact somewhere. I feel that connectivity, still. You know, to the kids I taught and coached. Earl. Lucille. My neighbor whose groceries I carried today. Have I been keepin’ count of people I may have helped? No. It was, you know, just one by one. It’s the little things. A kind word. A pat on the back. Confidence instilled in some kid that tells him, ‘I believe in you’ even when he doesn’t believe in himself. I mean, that ain’t nothin’.” ★ It took Charles 73 years to come to this sudden realization. He zig-zagged his way to it, criss-crossing a long and difficult road. But then, God always writes straight with crooked lines. No Charles, your life, our work... it ain’t nothin’. It is a great big something. It is, in fact, the Power of One.






Sometimes, we choose our demons. Sometimes, they choose us. The problem is, either way, once they get hold of you, they can take you down and leave you with nothing. It requires deep wells of inner strength and outer support to conquer them. Charles Bennett found the support he needed through the many programs of Catholic Charities. So did Tonya Farmer, a woman whose demon chose her. ★ Tonya was born bipolar, a disorder that wreaks havoc on one's life, one's relationships, and one's ability to perform daily tasks on or off the job. It is difficult to manage when you have all the means necessary to do so. But when you don't have those means and you don't know where to turn, it can lead you down some very dark paths. Tonya hit rock bottom before she was able to turn things around. Laid off from one job and unable to find another, Tonya, too, soon found herself on the streets. ★ "Being homeless is one step from death," Tonya shuddered. "There's nothing worse. One night I slept in a hospital just so I wouldn't have to sleep on the street. The street is dangerous." She moved from shelter to shelter, staying a few nights here, a few nights there. It was a precarious existence. Though the emergency shelters she frequented were well meaning... they were not well maintained. Nor was there ever any guarantee of an available bed. Tonya would often find herself carrying her bag from place to place, only to be turned away. ★ "That bag..." Tonya recalled, thinking of the suitcase that held everything in the world she owned. "That bag represented just what I'd been reduced to. I hated carrying it around. Like a reminder." She thought to herself: "There's gotta be a better life than this..." ★ There was. When there was overflow at one of the emergency shelters in town, Tonya was sent to My Sister's Place Women's Center, a Catholic Charities program. At the Women's Center, Tonya got all the help she needed to turn her life around. In addition to providing a safe place where Tonya could shower, receive her mail, and get three meals a day, My Sister's Place also provided her with important tools like case management, housing and job assistance, life skills training, and more. The counselors at My Sister's Place found out what earned benefits Tonya was eligible for and helped Tonya acquire health insurance. That enabled Tonya to get all the medical help she needed as well as secure a therapist. From there, Tonya was referred to My Sister's Place Lodge, a transitional housing program for homeless women with a disability. Women are allowed to live at My Sister's Place Lodge for up to two years while they work towards employment and self-sufficiency. Because of Catholic Charities and her own determination, Tonya achieved her goals within four months. ★ "Even though I was down, I never thought of myself as a victim. I knew I had it in me to overcome my problems. My counselors gave me the confidence to see that. My Sister's Place gave me the stability to do it." ★ Tonya is now fully employed and lives independently, thanks to Project FRESH Start, another Catholic Charities program that helps eligible individuals and families find affordable housing. "Tonya would have always been successful," explained one counselor. "She has what it takes to do so. We just helped her get there a little faster. In fact, she could be a homeowner one day. I think she is a perfect candidate for Habitat for Humanity." ★ From homelessness to home ownership. Anything is possible. As for Tonya, she is just grateful to "re-enter society." And where does she see herself in 5 years? "I think I might like to be a motivational speaker," Tonya imagined. "I want to help others, because somebody helped me. And because, no matter how down you get... you can get up again. You just have to believe in yourself. You just have to keep looking towards the future and have faith."






Landon Daines has had more surgeries in his six short years than most of us will have in a lifetime. An only child, Landon was born with a genetic condition, which results in severe physical and learning disabilities effecting development, speech, and communication. So far, Landon has undergone two heart operations, two palate surgeries, one eye surgery and numerous other minor procedures. He will require intensive therapy for a long time to come as well as individual attention in and out of the classroom. It is more than any mother might be expected to manage or afford, especially if she is – like Landon’s mother, Donna – a single parent and unemployed. For now, Donna relies heavily on her own mother who is her “rock” and moral support. Still, when it comes to navigating the uncharted territory of Landon’s childhood development and all his special needs, the responsibility falls squarely on Donna’s shoulders. ★ “In the beginning, I cried every day.” Donna admitted. “I wanted Landon to have every chance at a full and normal life, and I didn’t know how to make that happen for him.” ★ Luckily, she found a strong ally in Diana, the special education consultant at Catholic Charities’ St. Jerome’s Head Start. Head Start provides a range of comprehensive educational, health, parental involvement, and family support services to low-income families with children who are at-risk of falling behind. ★ While at Head Start, Landon began to learn what he needed to communicate and to catch up, including sign language and reading. ★ “Diana really took a special interest in Landon,” Donna admitted. “He used to cry when I dropped him off, but eventually he was waving me out the door. ‘Bye Mom. Go.’” Donna laughed. Diana wasn’t just Donna and Landon’s ally; she was a fierce and inexhaustible advocate for them both. “Diana is a real fighter,” Donna explained. “At St. Jerome’s, she made sure Landon got all the services he needed.” “She pulled all the strings, made all the connections,” confirmed St. Jerome’s director, Mary Gunning. Their advocacy didn’t begin or end in the classroom. ★ “Diana came to IEP meetings (Individual Education Program) with me. She was there for Landon’s assessments,” Donna continued. “You can’t fall through the cracks at Catholic Charities. When you’re with them, you’re the most important person in the world.” ★ Today, Landon is in kindergarten, plays little league, and is beginning to make new friends. “Landon is going to catch up. I just know it. He’s going to be OK,” Donna said with true conviction. Another example of the power of one to change lives. You see, Diana didn’t just help Landon. She empowered Donna. ★ “With all Landon’s medical problems and setbacks, it wasn’t always easy to know who to trust. I lost my faith in other people. I was afraid. Diana and St. Jerome’s helped me learn to trust again.” ★ “It’s true,” Mary Gunning confirmed. “In the beginning, Donna was a mouse. Unsure of herself. But the mouse is roaring now! She is learning to be her own advocate.” ★ “Head Start taught Landon to be brave. He is the strongest and sweetest little boy you’ll ever meet,” Donna said. “He is my world. He is my heart. If he can do it, I can do it. Thanks to Catholic Charities, I don’t have to do it alone.”







Imagine your reality as a living hell and ask yourself: just how hopeless would life have to be before you'd be willing to trade that hell for another? What kind of choice is that for any human being, especially a child? Yet, it is precisely the unbearable choice thousands of immigrant children from Central America have had to make in recent years. In the past twelve months alone, more than 70,000 unaccompanied children fled countries where extreme poverty exists and violent gang terror reigns to travel thousands of miles to the perceived safety of the United States. The violence in their native countries is so life threatening that families calculated the risks of the harrowing journey preferable to the certain brutality they would suffer at home. No child leaves the love of family and the only security she knows, tenuous as it may be, unless driven to do so. It is a heart-wrenching decision made only when there is nothing left to lose. ★ “By far, they are the bravest people I have ever met,” Valerie Twanmoh said of the Central American immigrants who come to the Esperanza Center seeking help. The Esperanza Center, a Catholic Charities program, offers language, citizenship, and computer literacy classes as well as immigration legal and family reunification services. It also provides healthcare and assists with translation, school enrollment, housing, and employment referrals. ★ “For our clients the Esperanza Center is ‘a one stop shop,’ ” explained Valerie who is the Center’s director. “Last year we served over 6,700 individuals. One person at a time. It’s the most gratifying work I’ve ever done. Especially when we are able to reunite family members.” ★ Recently, Esperanza helped reunite sisters Sonia and Graziela after nearly a decade long separation. Older sister, Sonia, was the first in her immediate family to leave her native Honduras. She made the agonizing trip nine years ago at the age of 25. On foot. With only the clothes on her back and a little bit of water for the brutal three week trek. She would not eat for twenty days as she made the 1,500-mile journey from Honduras through Guatemala and Mexico to the United States. It was a dangerous trip, especially for a young woman. The threat of sexual violence lurked behind every desert sagebrush. She was sick and malnourished and her only pair of shoes completely fell apart. But what she left behind was far worse. ★ “I saw family members beaten by gang members with machetes. People were murdered.” Sonia recalled tearfully. The memory was still raw nine years later. Eventually, Sonia made her way to Baltimore where she knew other Hondurans. Through the help of the Esperanza Center she was resettled, found employment as a waitress, and dreamed of bringing her other family members to the U.S. Though it would take nearly a decade, she never gave up hope. ★ “I took part of every paycheck and sent it back home to my family. It helped them survive when no money was coming in. It helped them send Graziela to me,” Sonia smiled, conveying no sign of the tremendous personal sacrifice it took on both ends to do so. ★ Fifteen-year-old Graziela arrived in the United States this past summer after a five day trip by jeep from Honduras. Upon arrival at the border Graziela was immediately sent to a California detention center by the authorities. It would be another 18 days before she was reunited with Sonia in Baltimore. ★ “Esperanza Center made everything possible. We could not do it without them,” Sonia said. “They help every step of the way.” At thirty-four, Sonia is more reserved and world weary than Graziela. She has seen and been through a lot. Graziela smiles more and even giggles. Only fifteen, she has been spared the worst. She is happy to be with Sonia who is now sister and mother to her. “Honduras cannot be home anymore,” Sonia explained. “This is home now. And we are very grateful.” ★ From the beginning, the Catholic Church has recognized a universal common good across borders. It is what the tale of the Good Samaritan is all about. The Church understands that every human being has a basic right to self-preservation. It is what every wave of immigration is about. And so, Catholic Charities will continue the work of caring for immigrants at both our Esperanza Center in Fells Point and hopefully at our St. Vincent’s Villa in Dulaney Valley where we will begin the work of welcoming 50 refugee children from Central America as they await family reunification. And we will care for them. One child at a time.





everly Butler may not have the life she planned for herself as a young woman... but she has the life she wants. Happily married with two sons, Bev worked in the important but uneventful world of database maintenance at a local university. But when her youngest son who is bipolar began to develop behavioral problems at a very young age, her life took a detour. He was admitted into what was then called the Villa Maria Residential Treatment Center — now called St. Vincent's Villa — a Catholic Charities program for families in crisis, where troubled children live apart from their families for a time. Although every attempt is made to serve children in their home and community, sometimes there are safety factors to consider and a program with 24-hour supervision and specially trained staff can be beneficial to both child and family. ★ While there, Bev's son got the assessment and therapy he needed and his behavior began to improve. Bev and her family were also advised on how to encourage and maintain the improvement once her son returned home. It was the beginning of what would be a very long journey with many ups and downs for Bev and her family. They knew of no one else in their position and had no way of really gauging how they were doing as time went by. She longed for interaction with other families who were in the same situation. What she would do next would change her life forever. ★ Bev approached St. Vincent's and suggested they add a family support group to their program. Catholic Charities recognized the need and asked Bev to spearhead the initiative. With that she switched careers, became a Family Support Specialist, and started the first family support group at St. Vincent's in 2002. ★ "My son gave me a gift. He led me to this work. And every time a family says to me, 'You saved our lives,'" Bev explained, "it reinforces this is where I need to be and what I am meant to do." ★ In addition to the support, assessment, and residential programs, St. Vincent's also offers a complete diagnostic and treatment program, case management, individual and family therapy, parental education, and much more. An important goal of Catholic Charities is to bring much of that work directly to the community. ★ "Community-based work is so important," Bev explained. "You don't have to come to St. Vincent's or enroll in the residential program to participate in our support groups, for instance. Catholic Charities understands it is important to meet the need where it lives." ★ Today, Bev oversees a growing number of support groups throughout the Baltimore region. "Through them, we are able to give families what I needed when I was in their position. It is so helpful for family members to talk with others who understand and have been through what they've been through," Bev explained. "We don't make the crisis disappear necessarily, but we help families get through it much easier. They come through it with their faith intact and their hope alive. And that's huge." ★ As a result, many family relationships are stabilized and strengthened and new relationships — friendships among the families — are built. "Catholic Charities and St. Vincent's had the wisdom to make all this happen. They had faith in me to start the program. They first helped me, and now thanks to them, I am able to help others, who will turn around and help the next family in crisis. ★ Whatever little thing I do... I know it will go forward." That's the power of one. Multiplied.





The first thing you notice when meeting the women of the Gibbons home is not their shared disability, but rather their shared love for one another. While it is true that the women who live in community here each have an intellectual disability, it is not the most distinguishing thing about any one of them. Linda is always smiling. Eileen has a great sense of humor. Barbara is nice to everybody. And Ernestine, well, Ernestine can put a 1,000-piece jigsaw puzzle together in 15 minutes flat! ★ The Gibbons home is one of 57 licensed residential sites currently run by Catholic Charities' Gallagher Services for individuals with intellectual disabilities. What Gibbons and other Gallagher homes like it provide is a sense of belonging for its residents and speaks to the transformative power of relationship and community. Ernestine and Barbara have lived together for 25 years. Eileen joined them 5 years ago and Linda moved in to complete the tight knit group 2 years ago. They are joined by Gibbons House manager, Donna Walker and Winifred Smith, their primary counselor who spends more than 40 hours a week at Gibbons. That is in addition to her full time job as a Baltimore City Public School Principal. "People ask me why I do it," Winnie explained. "I tell them, 'You don't get it. This isn't a job. This is my family'." At the heart of the program is the idea that I have as much to receive from the women as they do from me. ★ Places like Gibbons allow its residents to live independently, to work with dignity, to develop a sense of self-worth, and – most importantly – to love and be loved. It is the Catholic Charities difference. "Yeah... We love each other," Ernestine said with a smile. "I teach them to love and respect each other," explained Winnie, "and they teach me what love really is because they teach me to be present, to be patient, to be gentle." ★ They are, indeed, family. And – like any family – the best part of their day is coming home from work and sharing a meal and fun time together. They laugh and sing together and are experts at all things Wii, including dancing, bowling and – believe it or not – boxing! ★ "We all get along really well," Barbara confirmed. They have a lot to offer each other and the world and their love extends beyond the walls of the Gibbons home. "Every other Sunday, the girls and I pack up the van and go downtown to the streets of Baltimore to feed the homeless," Winnie explained. It is a remarkable example of how the power of one can change lives and how the power of community can change lives well beyond its own community. ★ "God is happy we're doing it," Linda said about feeding the hungry. And when asked how they felt about it, the women simply said, "It makes us sad." They might have said, "It makes us feel good." Instead, their answer taught an important lesson in empathy. Because these women knew, perhaps better than anyone, that relationship is not about 'what I can do for you' but about 'how we can be together' and recognize ourselves in each other. In those four little words, the Gibbons women conveyed the Gospel values we embrace at Catholic Charities: when one suffers, we all suffer. And when one is lifted up, we are all lifted up. Because we are all inextricably linked. One body, one spirit... one family.

One by one, thousands were served

★ ASSISTING PEOPLE LIVING IN POVERTY ON THEIR ROAD TO SELF SUFFICIENCY

We secured 1,328 housing placements for individuals who needed a stable place to live.

We secured job placements for 577 people who were out of work.

We served 522,126 meals to men, women, and children who were hungry.

We assisted 11,948 individuals with emergency, intake, and case management services.

★ SUPPORTING CHILDREN AND FAMILIES TO OVERCOME BARRIERS TOWARDS BETTER FUTURES

We provided holistic Head Start programs for 544 children and their families. Ninety percent of the 4-year-old children were assessed as being fully ready for kindergarten.

We operated three Special Education Schools where 80% (180 of 225) demonstrated mastery of their behavioral goals.

We assisted 26 people in obtaining their U.S. citizenship.

We reunited 481 unaccompanied minor children with their families, provided family reunification services to 400 sponsors, and represented 491 clients in other Immigration legal matters.

We taught English classes to immigrants to assist with their transition to the U.S. and 38% significantly increased their level of proficiency.

We placed 79 children with caring treatment foster care families.

We provided a total of 21,286 mental health assessments, consultations, and treatments for families and crisis interventions for adolescents in Baltimore's two largest hospitals.

We assisted 28 families with international adoptions, 265 families with pregnancy, parenting, and post-adoption services, and 133 families with kinship caregiver support.

We provided 4,165 welcoming, bilingual healthcare visits to 1,525 immigrants who have no other access to care.


